- 4. Pre-bid meeting shall be held at Khairahani Municipality, Office of Municipal Executive, Chitwan at 2076/09/25 (10<sup>th</sup> Jan, 2020) 2 PM.
- 5. Electronic bids must be submitted to the **Khairahani Municipality**, **Office of Municipal Executive**, **Chitwan** through PPMO website <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> on or before 12.00 noon on 2076/10/12 (26<sup>th</sup>Jan, 2020). Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2.00 PM on 2076/10/12** (**26<sup>th</sup>Jan, 2020**) at the Khairahani Municipality, Office of Municipal Executive, Chitwan. Bids must be valid for a period of 90 days i.e., up to **2077/01/12** (**24<sup>th</sup> April, 2020**) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs **252000.00**, which shall be valid for 30 days beyond the validity period of the bid i.e. **2077/02/10** (**23<sup>th</sup> May, 2020**).
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
